The Arizona Coalition for Military Families, the Governor's Council on Spinal and Head Injuries, and the Brain Injury Association of Arizona, in collaboration with the Phoenix VA, TriWest, the Arizona National Guard, Luke Air Force Base, and other community partners, are pleased to announce:

A Warrior's Journey: A Day of Sharing, Learning, and Support for Service Members and Veterans with TBI and their Families Warriors (Active Duty, Guard, Reserve, and Veterans) who have sustained a traumatic brain injury (TBI) and members of their families are invited to attend.

This invitation includes those who have any level of TBI—from the most severe injury to those who experienced a mild TBI or concussion. We encourage those who may also have other conditions in addition to their TBI, such as PTSD, depression, pain or sleep issues, to join us.

Audience members can choose to attend classes, join discussion groups, and/or spend time in the Community Resource Room talking to representatives of military, veteran, and civilian resource organizations.

Child care stipends are available for families who need them, so that the parents can focus on learning and connecting to resources. For teens of participating families (ages 13-17), a digital storytelling event hosted by Operation Military Kids (OMK) will be offered at the conference site. The teenagers will learn the basics of script-writing, story-boarding, audio/video recording, and using digital technology to create their own Speak Out Military Kids story—focusing on their experiences with having a military parent who has been injured. The day's activities included teambuilding, "feelings" activities, and hands-on interactive, technology-related activities.

Participants will use the OMK Mobile Technology Lab to create and edit their digital stories. There is no charge to participate in A Warrior's Journey or the Teen Digital Storytelling program.

Arizona's Eleventh Annual Transition Conference, Imagine It, Plan It, Do It! is a collaborative, cross-stakeholder professional development event aimed at providing meaningful and pertinent information needed in the transition planning process for youth and young adults with disabilities. This year's conference includes a dynamic array of national speakers, state level experts, and also includes youth, young adult, and family member participation.

Sessions contain content from the following strands: Community Partnerships, Family Voice, Secure Care, Career and Job Development, Accessing Community Resources/Medical and Social Empowerment, Youth and Young Adult Empowerment, Assistive Technology, and Curriculum and Instruction.

Early registration for Arizona's Eleventh Annual Transition Conference is now open and will end Friday, June 17, 2011. Standard registration begins Saturday, June 18, 2011, and ends Friday, September 9, 2011. This conference has been filled to capacity for the last two years, make sure to register early!

Please note the following registration details:

- Conference registration will be processed exclusively online for all participants;
- Early, standard, and late/walk-in registration periods significantly impact registration fees;
- Family and youth/young adult-focused strands will only be held on Monday and Tuesday. Registration fees and scholarship funding allow participants who register as a family member, youth, or young adult to attend the conference on October 3 and 4, 2011. Additional information about scholarships will be disseminated in June;
- Registration fees for educators, service agency providers, and other professionals allow participation in all three days of the conference;
- Scholarships continue to be available on a first-come, first-served basis for youth, young adults, and family members needing assistance with lodging or registration costs. Only youth/young adults aged 22 and younger and/or family members of eligible youth are eligible for scholarship funding; and
- There will be no allowance for single-day registration.

SPECIAL NOTES: The conference begins at 9:30 a.m. on Monday morning to accommodate participants traveling from out of town. Also, in order to be environmentally conscious, paper copies of handouts will not be provided at the conference.

Materials for all sessions will be posted online three weeks prior to the conference on the ADE/ESS Secondary Transition website; participants are asked to print and bring materials for sessions of interest.

Sun Van Fare Increase

At a public hearing held April 12, 2011, City of Tucson Mayor and Council voted to approve a transit fare increase effective July 1, 2011. Sun Van's one-way full fare will increase from \$2.50 to \$3. The one-way economy fare will increase from \$.80 to \$1. VOICE Support Group will NOT have a meeting in July or August. Group will start again on September 13th.

There will be NO regular COMPASS Support Group meeting in June, July OR August due to the hot weather. Group will resume on September 16th.

Don't Get Dropped from AHCCCS!

As of July 1, 2011: The AZ Legislature this session passed a bill to freeze enrollment in **AHCCCS** for the Prop. 204 population – childless adults with incomes between 33% and 100% of federal poverty level. For one person the federal poverty level is 903.00/monthly or \$10,836/ yearly. This means that NO NEW people will be able to apply for AHCCCS in this category after July 1, if the Centers for Medicare and Medicaid approve this change and a law suit doesn't stop it. It also means those already on AHCCCS in this category MUST renew their applications on time or they will be dropped from AHCCCS and unable to get back on, no matter what their medical need is. Most will have either a 6 month or 12 month renewal anniversary.

What you can do:

- Educate others about this change and encourage them to keep a look out for their renewal notice and fill it out promptly
- Go to the website to learn more information and let others know about it. They have a tool kit to help people.

Why do people drop off of AHCCCS?

- Thousands go off and on every month.
- If a person is healthy when the renewal date comes, they may not renew. When they get sick again, they re-apply, but they won't be able to do that after 7/1/11.
- They may have trouble understanding the renewal notice due to their disability.
- They need help to complete the process and don't know where to go
- They forget.
- In the past they could just reapply whenever they wanted to.

Bottom Line: You won't lose AHCCCS if you are on it by 7/1/11 and qualify <u>unless</u> you do not submit the renewal eligibility paperwork on time!

ADA.gov News -- Olmstead Update

The Department of Justice has released a new technical assistance document describing public entities' obligations and individuals' rights under the integration mandate of title II of the Americans with Disabilities Act (ADA) and the 1999 landmark Supreme Court decision, Olmstead v. L.C.

Additionally, in commemorating the 12th anniversary of the *Olmstead* decision yesterday, the department launched a new section of its ADA website, www.ada.gov/olmstead, providing information and resources about the decision and its enforcement. In addition to the newly created technical assistance document, users can visit the site to find briefs filed by the Department, as well as other materials relevant to this important area of law.

The department also expanded its existing ADA.gov E-mail subscription service to include Olmstead enforcement. To monitor developments, a subscription link is provided at www.ada.gov/olmstead.

Independent Living Rehabilitation Services

The Independent Living Rehabilitation Services (ILRS) program is a federally funded program through Title VII, Chapter I, Part B of the Rehabilitation Act.

Through this legislation, states are mandated to maximize leadership, empowerment, independence and productivity of individuals with disabilities by promoting a philosophy of independent living. This includes consumer control, peer support, self-help, self-determination, equal access and individual and systems advocacy.

The ILRS program is focused on providing four core services:

- Independent Living Skills training
- Information and referral to appropriate agencies or providers
- Individual and systems advocacy
- Peer support and counseling and/or mentoring

To be eligible, you must be a person with a significant physical, mental, cognitive or sensory impairment which substantially limits your ability to function independently within your family, your home and your community. There must be a reasonable expectation that ILRS will assist you to improve your ability to function, continue functioning or move towards functioning independently.

The ILRS program will accept referrals for individuals, who would like to achieve a selfdirected and independent lifestyle.

Not everyone with a disability is eligible to receive services through ILRS, but no person will be denied the right to apply.

Service are time-limited and always directed towards achieving an independent living goal. Individuals who meet eligibility criteria work closely with an ILRS counselor to identify objectives in the areas of personal and/or home management or integration into the community.

Services are provided based on individual needs, independent living goals and available agency funding. Some services are subject to a determination of the consumer's financial needs. You or your family may participate in the associated costs, but it is not a requirement for receiving services. If you become an ILRS client, your ILRS counselor will work with you to develop your Independent Living Plan.

Call the District office that you reside in and staff will put you in touch with an Independent Living counselor for the Rehabilitation Services Administration (RSA) in your area.
